### WINTER STORAGE CONTRACT TERMS AND CONDITIONS

1. Outside storage includes hauling, bottom washing, storage, and launching. It does not include scrubbing and scraping the bottom, covering the boat for the winter or engine winterization.
2. Responsibility for drain plug removal and replacement is the owner's.
3. Owners are not permitted to burn paint, run engines, use heaters, light stoves, store batteries, or use flammable materials unless special arrangements are made with the Marina Manager.
4. No electric cords may be left plugged in during the winter storage and no electric heaters may be used to minimize the possibility of fire.
5. The Marina Management is not responsible for fire, storm, theft, or ice damage and the boat owner agrees to hold Striper Marina, Inc. harmless in the event of such occurrences.
6. Boats not ready to be launched by contract time, because of the owner's negligence, will be subject to a moving charge.
7. Outside contractors or workers will not be permitted to work on any boat in the Marina unless a certificate of insurance is on file in the Marina office for said contractor or worker. The insurance is to cover comprehensive general liability, product liability, and personal injury in an amount not less than \$500,000. Any contractor or person hired to perform work or repairs by the boat owner, must sign in and out at the Marina office.
8. Beware – The vessel and its contents may be sold at public auction for failure to pay storage charges.
